1. a) Method One - Online Entry and Registration:

2. Make sure we’re able to find your registry. If we draw you as the winner, we’ll need to be able to find your registry by searching for your name or the email address that was used to create your PLN account.

3. The winner will be drawn on January 8th, 2026 so make sure to keep your registry active until then.
4. create your registry.
5. After you create your registry, tell us where to look for it (e.g. Amazon) in the text box on the contest entry page in Canada's Luckiest Baby OR by replying to an email from PLN that includes the Chance to Win your Baby Registry 2025 contest OR by emailing registries@parentlifenet.com. By submitting your registry to PLN in this manner, you are agreeing to the contest rules.
