

# **Parent Life Network - Chance to Win Your Baby Registry 2026 Contest Rules**

This contest is open to Canadian residents only. No purchase necessary to enter or win.

## **Contest Details**

The contest runs from January 1, 2026 at 12:00 a.m. Eastern Time to December 31, 2026 at 11:59:59 p.m. Eastern Time. The sponsor is 55 Rush Inc., parent company of Parent Life Network, located at 300-174 Spadina Ave. Toronto, ON, M5T 2C2. The prize draw will take place on January 8, 2027 at 2:00 p.m. Eastern Time in Toronto, Ontario. By entering, you agree to follow these rules.

## **Who Can Enter**

You can enter this contest if you are a legal resident of Canada who has reached 18 years of age or older as of the date you enter. Canadian residents may be residing anywhere in the world at the time of entry.

You cannot enter if you are an employee, officer, director, agent, representative, or family member of 55 Rush Inc., Parent Life Network, or their advertising and promotion agencies, or if you live with someone who is. By entering, you agree to follow these rules and all applicable laws.

If there's a dispute about who submitted an entry, we'll consider it submitted by the person who owns the email address used. That means the person to whom the email address is assigned by the email provider or organization.

## **Prize**

There is one grand prize of up to \$2,500. The winner will receive a cheque for the total value of their submitted baby registry up to a maximum of \$2,500. All amounts in these rules are in Canadian dollars.

## How to Enter

There are two ways to enter this contest.

**Method 1: Online Entry.** You must create an online baby registry at any retailer that offers online registries. We recommend Amazon for the best prices, widest selection, and ease of creation. Make sure your registry is searchable by your name or by the email address you use to create your Parent Life Network account. Keep your registry active until the winner is drawn on January 8, 2027.

After you create your registry, tell us where to look for it by doing one of the following: enter the registry location in the text box on the contest entry page on Canada's Luckiest Baby, reply to an email from Parent Life Network that includes information about this contest, or email [registries@parentlifenetwork.com](mailto:registries@parentlifenetwork.com) with your registry details. By submitting your registry information to Parent Life Network in this manner, you are agreeing to these contest rules.

**Method 2: Mail-In Entry.** Write your full name, email address, phone number, complete mailing address including postal code, and signature on a plain white piece of paper no larger than 8.5 by 11 inches. Include a request to be registered and entered into the contest. Using multiple names, email addresses, identities, or accounts to enter more than once is not allowed and may result in all of your entries being disqualified. Incomplete entries or entries with false information will be disqualified.

## How Winners Are Selected

On January 8, 2027 at 2:00 p.m. Eastern Time in Toronto, we will randomly select one entry from all eligible entries received during the contest period. The person who owns the selected entry will be eligible to win the prize, subject to verification and compliance with these rules.

Your odds of winning depend on the total number of eligible entries we receive.

## Winner Verification Process

We will attempt to contact the selected winner by email using the information provided when you entered, within two days of the draw date. If we can't contact you within five days of when we notified you, you may be disqualified and forfeit all rights to the prize. We may then randomly select an alternate winner. We are not responsible if you don't receive our notification due to spam filters, incorrect contact information, or other email delivery issues.

To be declared the winner, you must correctly answer a time-limited math skill-testing question without any assistance and sign and return a legal release form within five business days of notification by email. The release form confirms you followed the rules, accepts the prize as awarded, releases us from liability, and lets us use your name, image, likeness, and statements about the prize for publicity and promotional purposes

without additional compensation.

## Prize Delivery
