

# PLN Monthly \$1,000 Giveaway Contest Rules

This contest is open to Canadian residents only. No purchase necessary to enter or win.

## Contest Details

The contest runs from January 1, 2026 at 12:00:00 a.m. Eastern Time to December 31, 2026 at 11:59:59 p.m. Eastern Time. The sponsor is 55 Rush Inc., the parent company of Parent Life Network, located at 300-174 Spadina Ave. Toronto, ON, M5T 2C2. Prize draws will take place on the first of each month between February 1, 2026 and January 1, 2027 in Toronto, Ontario. If the first of the month falls on a non-business day, the draw will be conducted on the first business day following the first of the month. By entering, you agree to follow these rules.

## Who Can Enter

You can enter this contest if you are a legal resident of Canada who has reached the age of majority in your province or territory.

You cannot enter if you are an employee, officer, director, or agent of 55 Rush Inc., Parent Life Network, or any contest partners, or if you live with someone who is. By entering, you agree to follow these rules and all applicable laws.

If there's a dispute about who submitted an entry, we'll consider it submitted by the person who owns the email address used. That means the person to whom the email address is assigned by the email provider or organization.

## How to Enter

There are two ways to enter this contest.

Method 1: Online Entry. Log in to an active Parent Life Network campaign on the <https://parentlifenetwork.55rush.com/> domain and complete a "Contest Offer" as outlined in the

details of each offer. Or complete an offer by clicking a link provided in PLN email communications.

To enter using this method, you must have an active Parent Life Network account, and/or be a current subscriber to the PLN mailing list. Incomplete accounts, accounts with false information, or accounts not verified by email will be disqualified. Only fully completed accounts validated by email received during the contest period will be accepted.

Once you complete an offer, you will receive one entry into the contest and be registered for the duration of the contest.

**Method 2: Mail-In Entry.** Write your full name, email address, phone number, complete mailing address including postal code, and signature on a plain white piece of paper no larger than 8.5 by 11 inches. Your mail-in entry must be received during the contest period. Each mail-in entry must be sent in a separate envelope with sufficient postage. Mass mail-in entries in the same envelope will be void. ## **Extra Entries**

You can earn additional entries by completing additional offers on the Parent Life Network website. Each contestant may only earn one entry per offer completed. Each entry earned will be valid for every monthly draw held following the awarding of that entry.

On the first of each month between February 1, 2026 and January 1, 2027, one (1) potential winner will be randomly selected from all eligible entries received during the contest period. If the first of the month falls on a non-business day, the draw will be conducted on the first business day following the first of the month.

Your odds of winning depend on the total number of eligible entries we receive.

## **Winner Verification Process**

We will contact the selected winner by email using the information provided when you entered, within two (2) days following the winner selection. If we can't contact you, you are ineligible, you fail to claim the prize within five (5) days from the time award notification was sent, or you fail to meet the requirements below, you may be disqualified and we may select an alternate winner.

To be declared the winner, you must:

- Correctly answer a math skill-testing question in the manner prescribed.
- Sign and return a completed declaration and release form as required.
